Our Children....

We have been enjoying our two boys, Simphiwe and SThembiso after things settled with the comings and goings of other babies and children during December.

Mid February we had a visit from the social worker and 2 ladies from another ministry that has cluster foster homes. These are small homes on the same property with six children in each headed by a Gogo (granny). When they take in children it is for the long term. Simphiwe has left us to go live there, we keep in touch to see how he is doing and have visited him. At this point in time, he is not adjusting well, which is not surprising after all he has gone through in his short life. Please be praying for him.

April 12 is our court date to go before the magistrate to finalize SThembiso's status as foster. We have been informed that we

will not be able to receive the foster grant, we haven't collected anything to this point anyway. SThembiso has been growing so much, he is almost 6 months old and is very strong, wanting to sit or stand all the time!

Mid March we reconnected with a friend, Pam, who also with her husband have opened their home for the past 30 years to abandoned, abused and neglected children. This after having already raised their own children, so are now in their mid seventies. When the last baby came to them they had decided that it needed to be the final child. As they are so well known for what they do, often mothers or family just bring the children straight to them.

The last three that came to them needed a home to go to, we were more than happy to provide that home. Another confirmation that we are doing what the Lord wants us to—He brings the babies and children in spite of a broken system.

The first of the year a new ruling was made, that a form needed to be signed by Social Development before the magistrate could sign detention orders to place children. Unfortunately, Social Development does not want to sign these forms!

The director of Child Welfare decided something had to be done, so with an affidavit in hand, she went to court stating the above problem and that they had abandoned babies in the hospital waiting for a place to go. The courts agreed with her and she was able to get an okay to forgo the form at this time—good news for us!!

Just before Easter, we were able to fetch 2 of the 3 children that were coming to us—a 2 year old, Wandile and his 3 year old cousin, Sbonga. The third is a 9 month old Con'd...

Building Fund...

While we were in the states, we made an appeal to raise \$100,000 in one year to purchase the property we presently occupy.

The Lord led us to and provided the property where we are, knowing that it would be perfect for our needs. The house is large enough that we are able to live here with up to 6 babies/children. The lot has enough space to put up a couple more buildings to be used for storage, visiting family, friends, volunteers, and as another home for

children in the future. Bordering property is also available to be purchased for further expansion if the Lord leads in that direction.

Our written agreement with the current owners made provision for them to charge us rent if their circumstances changed and they had the need. We received a phone call that one of their sources of income had dried up and they are expecting their 5th child. So their needs have increased and we have been paying rent for two

months now.

The rent they are charging is less than the loan payment and we still have the option to purchase within the 2 years.

As we said earlier, we strongly feel that the Lord has brought us to this place. He has confirmed this through a chain of events that brought us here plus the community and area support for us in spite of encountering roadblocks with government agencies.

Continue to pray as we meet the special needs of each child—those abandoned by mother by choice and those whose mother has passed away. This is very time consuming, but so worth it!!






Building cont'd...
